- Diversity (Huntington) -
  - (Working from home disadvantages students unequally. Some of our graduate and undergraduate students lack a home computer, internet access, a desk or a private space to work or attend a zoom meeting. Some are caring for young children and/or aging relatives, or have gone home to pandemic hotspots in other time zones. Others (or their family members, roommates, or partners) have lost their jobs and are struggling to pay rent and basic needs now, and worried about job prospects for the future. Some have health issues that make this time particularly scary or disabilities that make remote learning particularly challenging. Please keep these issues in mind in your course expectations and messaging for students right now.
  - Meeting basic accessibility standards for electronic teaching materials is arguably more important than ever. We are all overwhelmed, so to make it easy we want to point you to two key handouts our advising team has highlighted on the <u>diversity</u> resources section of the ESS website on Accessibility 101:
    - <u>Accessibility Checklists for MS Word, PDFs, and PPTs</u> Provides short checklists for MS Word, PDFs, and PPTs to confirm whether documents meet basic accessibility standards.
    - <u>Accessible Conference Presentations</u> This handout provides a sample of the information to help presenters make their presentations more accessible.
  - The challenge of delivering remote instruction presents an opportunity. Many of us are facing a tremendous challenge rethinking learning goals and delivery methods for classroom and field instruction. With this challenge comes a once in a lifetime opportunity to reenvision effective classroom practices, and access, equity, respect and safety in field education and field research in the Earth and Space sciences profession. Do nothing "extra" now! We just want to plant the idea in your minds that when the dust settles, we will be able to build on the work you are doing now to improve effectiveness and equity for in-person classroom and field instruction and research experiences for everyone.
